### 2017 Shaker Village Craft Fair Dates: August 5 + 6

Set Up: Friday, August 4, 9am-9pm

*Goal*: Produce a high quality event with appeal to the general public where skilled artisans will display and sell their work.

Space Rental, Equipment and Facilities: Space in the craft fair area will measure 12' x 12'. Each space will rent for \$200 for the entire weekend, and more than one space is available, if needed. Vendors must provide awnings, tables, chairs and staffing for their booths. Food service and rest room facilities also will be available near the craft fair area.

Location and Hours of Operation: The Shaker Village Craft Fair is located within The Historic Centre near the West Family Wash House, West Family Dwelling and the Carpenters' Shop. Hours of operation are 9:30 a.m. – 5 p.m. on Saturday and 10 a.m. – 4:30 p.m. on Sunday. Shaker Village will require all vendors to be open for business during these hours. The craft fair area will be secured during off hours.

*Proceeds from Sales:* Vendors will receive all proceeds from sales and will be responsible for collecting their own Kentucky Sales Tax.

Vendor Selection: Vendors will be selected by a jury process.

Accommodations: For vendors who wish to stay overnight at Shaker Village, rooms will be available on a first-come basis. There also are several motels in Harrodsburg where rooms will be available (see motel list on page 5). While Shaker Village does not permit RVs or tent camping on its property, there is a campground less than 10 miles away on Herrington Lake.

We look forward to receiving your application forms. Please remember to include the \$15 entry fee made payable to Shaker Village of Pleasant Hill. Thank you for showing an interest in Craft Fair.

- Retail price of each item or a price list MUST be included.

# JURY PROCESS 2017 SHAKER VILLAGE CRAFT FAIR

High-quality traditional crafts constructed from the following mediums will be considered by a panel of jurors for participation in the Shaker Village Craft Fair. The following mediums will be considered: clay, fiber, glass, leather, metal, mixed-media, wood and other materials. Works submitted in these mediums must employ techniques universally considered as craft.

Jurors will judge work for eligibility standards of design, technique and originality. Only work of the highest quality within these standards will be accepted for display and sale at the Shaker Village Craft Fair. There are caps for each medium represented to ensure diversification.

#### All entries must be submitted no later than April 30, 2017.

Written notification of the jury results will be mailed approximately four weeks following the jury session or no later than April 30, 2017.

The following categories are NOT eligible:

- Works executed from COMMERCIAL items, molds or kits.
- Items constructed solely by assembling purchased commercial items or mere decoration of commercially produced objects.

#### **RETURN OF SAMPLES**

Applicants are responsible for picking up samples between 9 a.m. and 3 p.m. at the Shaker Village warehouse between May 1, 2017 and May 15, 2017 or MUST provide return shipping payment. A check or money order payable to Shaker Village of Pleasant Hill with a self-addressed shipping label must be included with the application for return shipment.

Entrants must provide appropriate and sufficient packing materials along with specific packing instructions.

Written notification of the jury results will be mailed approximately two weeks following the jury session or no later than May 15, 2017. Results will not be given over the telephone.
