# **EQUESTRIAN REGISTRATION GUIDELINES**

### Shaker Village of Pleasant Hill

Shaker Village of Pleasant Hill is one of the premier riding destinations in Kentucky. Your support and riding fees enable Shaker Village to continuously maintain and improve the trails and your riding experience. Please follow these guidelines during your visit.

**DAILY REGISTRATION IS REQUIRED.** Equestrians may self-register at the Equestrian Check-In Station near The Stable or the Shaker Village Welcome Center. Trailer parking is located behind The Stable.

DAILY RIDING FEE \$10.00 per person

#### **DAILY SELF-REGISTRATION**

Self-registration is only available to those paying with the exact cash amount or check. All others must register at the Shaker Village Welcome Center.

- 1. After parking in the designated horse trailer parking, follow the directional signage to the Equestrian Check-In Station. Enter the door on the side of the black metal building.
- 2. The light switch is located to the right of the door.
- 3. Complete the form on the fee deposit envelope and insert the daily riding fee(s) into the envelope. No change will be available.
- 4. Tear off the matching numbered tab and seal envelope.
- 5. Complete and sign the Property Usage Waiver. A waiver must be completed every day of trail use.
- 6. Place the deposit envelope and Property Usage Waiver in the deposit box mounted on the wall.
- 7. Display the numbered tab face up on the driver's side dashboard of your vehicle.

Shaker Village of Pleasant Hill staff monitor the equestrian area for compliance.

#### **ANNUAL EQUESTRIAN PASS**

If you have purchased an annual pass, please place your pass face up on the driver's side dashboard of your vehicle. Annual pass holders are not required to complete a Property Usage Waiver each time they use the trails. If you have someone with you who is not an annual pass holder they are required to register and pay the daily riding fee as described above. Annual Equestrian Passes may be purchased at the Welcome Center for \$160 per year (non-transferable), or \$200 for both a combined Annual Equestrian and Annual Village Pass.



# TRAIL REGULATIONS

## Shaker Village of Pleasant Hill

- All trail users must register and sign a property usage waiver and pay appropriate daily usage fees.
- Trails are open from dawn until dusk.
- No motorized vehicles are allowed off paved roadways.
- No restroom facilities, drinking water or trash receptacles are available on the trails. Portable restroom facilities are located next to The Stable and at Shaker Landing.
- Trails travel through protected areas. Do not disturb or collect plants, animals, rocks, fossils or remains of human history. Please enter creeks only in designated crossing areas.
- Trails pass abandoned mine sites. Do not enter mine sites.
- Parts of Shawnee Run Trail, Towering Sycamore Trail, Pelly Trail and Tanyard Trail are seasonal and may be impassable due to high water.
- Dogs are only permitted on Village Loop, River Road Trail and Palisades Trail.
- Horse trailers must park in the designated area behind The Stable.
- Shaker Village does not provide horses for trail riding.
- Hikers and cyclists yield to equestrians on trails.
- Hunting on Shaker Village property is prohibited.
- At this time, no fishing is available onsite except at the pond near the Welcome Center, with paid admission and a valid fishing license. Fishing is catch and release only.
- If you pack it in, pack it out.
