We are now ready to begin the application process for the 2020 Shaker Village Craft Fair. **2020 Shaker Village Craft Fair Dates: August 1<sup>st</sup> & 2<sup>nd</sup>, 2020**

**Set Up: Friday July 31<sup>st</sup> 9am-9pm**

**Goal:** Produce a high-quality event with appeal to the general public where skilled artisans will display and sell their work.

**Space Rental, Equipment and Facilities:** The booth fee is \$200 for each 12x12 foot space. More than one space is available. Vendors must provide tents, tables, chairs and staffing for their booths. Food service and rest room facilities will also be available near the craft fair area.

**Location and Hours of Operation:** The Shaker Village Craft Fair is located within the main village touring area. Hours of operation are 10am-5pm Saturday and Sunday. Shaker Village will require all vendors to be open for business during these hours. The craft fair area will be secured during off hours.

**Proceeds from Sales:** Vendors will receive all proceeds from sales and will be responsible for collecting their own Kentucky Sales Tax.

**Vendor Selection:** Vendors will be selected by a jury process.

**Accommodations:** For vendors who wish to stay overnight at Shaker Village, rooms will be available on a first-come basis. There are also several hotels in Harrodsburg where rooms will be available. While Shaker Village does not permit RVs or tent camping on its property, there is a campground less than ten miles away on Herrington Lake.\*

We look forward to receiving your application forms. Please remember to include the \$15 entry fee made payable to **Shaker Village of Pleasant Hill**. Thank you for showing an interest in our craft fair.

## INSTRUCTIONS FOR SLIDE/PHOTO ENTRIES

All entries must be postmarked NO LATER than April 30, 2020.

- Entrants may submit up to four items for inclusion in the Shaker Village Craft Fair jury process. No more than two images per item should be submitted.
- Photographs should be in color and labelled.
- Each item must be accompanied by “Description Form.” To assist jurors in the process, please be as specific and complete as possible.
- Retail price of each item or a price list **MUST** be included.
- Please enclose a self-addressed, stamped envelope for returning your images

## JURY PROCESS

Quality constructed handcrafts from the following mediums will be considered for participation in the Shaker Village Craft Fair. The following mediums will be considered: clay, fiber, glass, leather, metal, mixed-media, wood and other materials. Works submitted in these mediums must employ techniques universally considered as craft. Use of commercial or trademarked images will not be considered.

All entries must be submitted no later than April 30, 2020.

## RETURN OF SAMPLES

Applicants are responsible for picking up samples between 9am -3pm at the Shaker Village Warehouse between May 8-15, 2020 or **MUST** provide a return shipping payment. A check or money order payable to Shaker Village of Pleasant Hill, with a self-addressed shipping label must be included with the application for return shipment.

Written notification of the jury results will be mailed approximately two weeks following the jury session or no later than May 15, 2020. Results will not be given over the telephone.
