In exchange for me and/or my child being permitted to participate in these activities, for myself, my child, my heirs, guardians, and legal representatives, I release and agree not to make or bring any claim of any kind against Rood and Riddle Equine Hospital, Long Run Woodford Hounds or its Sponsors, Masters, Officers, Directors, Members, Employees, or Guests, or any Landowners, Landholder or other persons making property available for Long Run Woodford Hounds, for any injury (including death), to me and/or my child or any damage to my property whether from anyone's negligence or not, or any other cause, arising out of my and/or my child's participation in these dangerous horseback riding, foxhunting or related activities; and I also agree if anyone makes any claims because of any injury to me and/or my child (including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims.
